ORDER

2. The CE has reported that none of the said Asst.Exc.Engineers has availed regular leave during their probation period and has certified that the work and conduct of the incumbents are good. Disciplinary action for major penalty has been initiated against Smt. Beena Narayanan by issuing show cause notice no.335/EW1/2017/LSGD dtd 27.01.2018, which is an impediment in the satisfactorily declaration of her probation, whereas the disciplinary actions pending against Sri. Jose H. Jones and Smt. Lajitha V. A. are only for minor charges.

3. In the above circumstances, the probation of **four Asst.Exe.Engineers namely Sri. Jipson Jose, Sri. Jose H. Jones, Smt. Lajitha V. A. and Sri. Vijayakumar S.,** in the cadre of Asst.Exc.Engineer, are declared to be satisfactorily completed w.c.f the dates noted against them as appended to this GO, as per Rule 20 (b) Part-II of KS & SSRs and orders issued accordingly.
