ORDER

The Chief Engineer (Administration), Planning, PWD as per the letter read as 2nd paper above had furnished clarification in connection with the realization of loss on account of termination of Contract- Section 2116.2.2 of KPWD Manual.

(2) In view of above, Government are pleased to modify the existing Clause 2116.2.1 of Kerala PWD Manual as follows:

An amount equal to 30% of the cost of the remaining works at agreed rates of the terminated contract shall be recovered from the defaulted contractor towards the risk and cost. The contractor shall be directed to remit the risk and cost amount within three months. There is no need to wait till the work is arranged alternatively through another contractor and the total loss sustainable due to the default of the original contractor is assessed. Such loss, if any, shall be realized after completion of the work. If he fails to remit the amount within stipulated period as directed by the agreement authority, (minimum one month and maximum three months, based on the amount to be remitted) from date of order, following steps can be adopted for realization of loss. The amount can be realized from the following.

- (i) EMD / Security
- (ii) Bill amount / retention if any due to the contract
- (iii) Any dues from department to the Contract
- (iv) Bank Guarantee/Performance Guarantee or By filing civil suit against the Contractor.
- (3) The Chief Engineer(Admin), PWD shall modify the Kerala PWD Manual accordingly.
