Assistant Engineers were notified vide reference cited 2nd. Sri Sudheer B while working as First Grade Overseer in Anthoor Municipality was suspended from service in connection with the irregularities found in issuing Occupancy Certificate to an auditorium at Kanur desam in Anthoor Municipality, Kannur as per ref cited 3rd. His name is previously included in the select list for promotion of First Grade Overseers to the post of Assistant Engineers vide ref cited 2nd. Subsequently he got promotion to the post of Assistant Engineer vide ref cited 4th. The promotion in respect of Sri. Sudheer was cancelled vide ref cited 5th since he was under suspension. As per ref cited 6th Government directed to reinstate him in service. He is presently working as First Grade Overseer in Kottayam Municipality. As per ref cited 8th Sri Sudheer B was exonerated from statement of allegations & disciplinary actions against him.

Consequently he is eligible for promotion to the post of Assistant Engineer with effect from the 22/08/2019, ie the date of effect of promotion to his immediate junior. The Seniority in the promotion cadre will come in to effect from 22/08/2019 onwards. But the Monetary Benefits in the promotion post will be effected only from the date of joining duty in the promotion post. Vide reference cited 9th he submitted an application for considering his promotion with retrospective effect.

In the above circumstances Sri Sudheer B, First Grade Overseer selected by the DPC held on 11/06/2019 was eligible for notional promotion as Assistant Engineer under Certificate Quota in the scale of Pay ₹. 55200 – 115300/- as per provisions contained in the special rule cited 1st and posted to the station noted against his name.

The promote will be on probation for a period of two years on duty within a continuous period of three years from the date of joining duty. Accountant Test (Lower), Kerala PWD Test and Kerala PWD Manual Tests for completing the probation in the category of Assistant Engineer. The Controlling Officer concerned is directed to submit their service book to the Accountant General (A&E) Kerala, Branch: Thrissur after recording the joining in the posted station for verification of service.

The controlling officer concerned is directed to relieve the promote immediately without waiting for the substitutes. The date of joining may be reported in due-course.

The newly promoted Assistant Engineer is liable to be transferred according to the request received from the existing Assistant Engineers at the time of General Transfer.
