K. were provisionally promoted to the cadre of Assistant Executive Engineer and their provisional service in the Asst.Exe.Engineer cadre were regularised vide the GO read as 2<sup>nd</sup> paper above, whereas Sri. K. P. Soman was regularly promoted to the cadre of Asst.Exe.Engineer vide the GO read as 1<sup>st</sup> paper above.

2. The Chief Engineer has reported that the above mentioned 5 Asst.Exe.Engineers, except Sri. Roy Philip has not availed any regular leave during their probation period, whereas Sri. Roy Philip has availed Half Pay Leave for the period from 14.05.2013 to 09.06.2013 and Earned Leave from 10.06.2013 to 27.06.2013, during his probation period. Hence the Chief Engineer has recommended for the satisfactorily declaration of their probation in the Assistant Executive Engineer cadre.






