ORDER

As per Government order read 1<sup>st</sup> above consolidated guidelines have been issued incorporating the relevant provisions of all existing government orders and Circulars regarding accreditation, selection and execution of public works in the State, in order to avoid ambiguity.

As per Government order read 2<sup>nd</sup> above, for estimates of works costing up to Rs. 1 crore Administrative Departments can award works (including repair works) directly to Non PMC Accredited agencies without competitive bidding subject to the condition that works thus awarded are being executed by them within applicable Schedule of Rates.

Several requests are being received to accord sanction retrospective effect to Government order read as 2<sup>nd</sup> above from 28/4/2021 for smooth implementation of minor and emergent works.

Government after having examined the matter in detail and are pleased to modify the government order read 2<sup>nd</sup> above according retrospective effect from 28/4/2021.
