The Director of Panchayats introduced the subject. The Committee approved the 2020-2021 Annual action Plan Proposal submitted to the Central Empowered Committee as per J4/27090/2018 dated.25.04.2020. The committee discussed the implementation of 2020-2021 financial year's action plan of Rs. 44.34 crore approved by the Central Empowered committee and decided to give administrative sanction for 2020-2021 annual plan considering the following.

1. Annual Action Plan Implementation

KILA is the implementing agency of the components Capacity building and Training, SPRC, DPRC.
 Training programs are being implemented online. KILA will also train new elected representatives

when they are in place.

- Technical support to GPs Assistant Engineers appointed in 99 Gramapanchayats during the last financial year under this component are allowed to continue in current financial year. Chief Engineer, LSGD proposed an enhancement of pay of Assistant Engineers. At present the monthly wages of Assistant Engineers is Rs. 25,000/-. It decided to give an increase of Rs. 2,500/- in the monthly wages of Assistant Engineers those who are still continuing from last year.
- The Chief Engineer reported that Assistant Engineers are required in 146 more Gram Panchayats under this component for 2020-2021 financial year. This can be allowed.
- The Assistant Engineers should also be used for water sanitation activities.
- common service centers Establishment of common service centers allowed in Gramapanchayats where Akshaya Centers are insufficient. Gramapanchayats shall be allowed to run these centers.
- The Director of panchayats was instructed to submit a detailed proposal to government regarding the project Two way video terminal / Satellite Interactive Terminal (SIT) for setting up virtual classrooms in 14 District Panchayats and Panchayat Directorate.

2. SATCOM - Pending Payment to M/s. Progility Technologies

A proposal in this regard is pending with the government. It was decided to take action subject to the approval of the Finance Department. Some members sought clarification on the subject. Therefore, it was decided to arrange a meeting with technical experts from the State IT Mission. It was also decided to invite representatives of M/S progility technologies in the meeting.
