Sub:- Budget Speech 2017-18 - Implementation of projects under KIIFB - Coastal Highway Project reg;

Government vide G.O(Rt)No.425/2017/PWD dated 30.03.2017 had entrusted NATPAC and Chief Engineer (NH) PWD to conduct a feasibility study of a Coastal Highway across the nine coastal districts of Kerala. NATPAC along with the territorial Engineers from the NH wing conducted the study and submitted a report to Government. The Chief Engineer NH has recommended the alignment subsequent to which Government vide G.O(Rt)No.679/2017/PWD dated 21.05.2017 approved the Coastal Highway alignment. The project was accorded in-principle sanction vide G.O(Rt)No.942/2017/PWD dated 10.07.2017. The estimated project cost is 650 cr. Implementation will be the responsibility of Kerala Road Fund Board, a special purpose vehicle for Infra Projects.

The length of the coastal Highway is around 650 Kms., which includes mainly road stretches belonging to roads wing of PWD, NH wing of PWD, certain LSGD roads and a few stretches of coastal roads belonging to the Harbour Engineering Dept. Certain links of the proposed Highway are green field stretches. A meeting of all MLAs of coastal areas was convened on 28/09/2018 by Hon'ble Minister for Public Works and Registration and there was a general understanding that the project should takeoff at the earliest. In certain stretches alternative alignments will also be studied and the best one finally selected.

As some short stretches of the alignment come under your Department, I would request you to depute officers to the meetings to be convened with MLAS/Peoples representatives for those road stretches relevant to your Department. The meeting schedule will be informed in due course. You may also kindly bear in mind while taking up new works/major repair works
