Energy Conservation Building Code (ECBC) has been notified by the Central Government under section 14 (p) read with Section 56(2) of the Energy Conservation Act 2001, Central Act 52 of 2001. ECBC covers building envelope, heating ventilation, and air conditioning system, interior and exterior lighting system, service hot water, electrical power system and motors with respect to energy efficiency at the design stage. EC Act 2001 in Section 15 provides the State Government, by rules made by it, to specify and notify ECBC and gives powers to direct every owner or occupier of a building or building complex being a designated consumer to comply with the provisions of ECBC.


Energy Management Centre - Kerala, the State Designate Agency (SDA) to implement the EC Act in Kerala, is actively pursuing capacity building efforts in ECBC and notification of ECBC in the State. EMC had conducted two ECBC training programmes on September - 2012 at Kochi and October - 2013 at Thiruvananthapuram for Engineers and Architects. In connection with the above subject third capacity building hands on workshop is being arranged. The total number of participants in this programme is limited to about 60.

We request you to nominate 15 - 20 numbers of formally qualified and experienced Engineers engaged in design and construction encompassing building envelope, HVAC, lighting and other electrical system and MEP working consultants from your organization. The participants are requested to bring their laptops for the programme.

The trained Personal/Engineers/Architects may act as resource person in design construction and compliance verification of ECBC in the State. Considering the role of your organization in the building sector in the State, we request you to make use this opportunity for the noble cause of Energy Efficiency by submitting the nominations in the attached format so as to reach us before 16<sup>th</sup> December 2013 by email (emck@keralaenergy.gov.in) /Fax/ post.
