ORDER

The Chief Engineer, LSGD vide letter read as 3rd paper above has reported that 564 Ministerial posts from Public Works Department and 364 Ministerial posts from Irrigation Department of various categories have been accommodated to Local Self Government Engineering Wing Department vide Government Orders read as 1st and 2nd papers above. Out of this 928 ministerial posts accommodated to the Ministerial Wing of LSG Engineering Department, only 389 staff actually joined in this cadre. As such there are 17 posts of Junior Superintendents, 189 post of UD Clerks and 35 posts of UD Typists are lying vacant. Hence the Chief Engineer, LSGD has submitted a proposal, vide 3rd paper above, for extending provisional promotion to the staff attached with the Ministerial Wing of Local Self Government (Engineering Wing) Department for the category of Administrative Assistant, Junior Superintendent, UD Clerk (Senior Clerk), UD Typist (Senior Typist) in the existing vacancy.

Government have examined the matter in detail. Since ministerial cadre for LSGD (Engineering Wing) has not been created yet, the ministerial staff attached to LSGD (Engineering Wing) ever since its formation has not been granted any promotion and allied benefits. Also at present a tendency is prevailing to obtain favourable orders from Hon'ble Court, so as to go back to their respective parent department. As such the day today functions in LSGD (Engineering Wing) are not efficiently carried out due to the scarcity of ministerial staff. In order to avoid this bad situation Government are pleased to accord sanction to the Chief Engineer, LSGD for granting temporary promotion to the eligible candidates upto the post of Junior Superintendents under Rule 31 (a) (i) Part II KS & SSRs, in relaxation of the ban subject to the following conditions:

1. Only optees can be promoted.
2. The promotion may be effected from a provisional seniority list so as to include all optees in the list.
3. The provisional promotion can be given only to sanctioned vacant post.
4. The vacancies occur in the entry cadre may be reported to Public Service Commission for fresh recruitments.
5. The case of regular promotion / regularisation of temporary appointment will be considered only when all the opted employees are formally absorbed in the LSG (Engineering Wing) Department after fixing the norms of absorption and after publishing the seniority lists.

Provisional promotion to the category of Administrative Assistant will be issued by Government.
