ORDER

MPLADS is implemented in the State following the State procedure ie either PWD or LSGD. While following LSGD procedure, the works may be entrusted with beneficiary committees also. Vide Government Order read as 1<sup>st</sup> above, the present upper ceiling of MPLADS works implemented through the beneficiary committees of Panchayati Raj Institution without tender process is limited to Rs. 5 lakhs. In the High level Co-ordination Committee meeting held on 11/04/2012, Hon'ble MPs have requested Government and decided to initiate steps to enhance the present ceiling. As per the Government Order read as 2<sup>nd</sup> paper above, Government have revised the upper limit of estimate amount of LSGD works entrusted with beneficiary committees to Rs.15 lakhs as the earlier amount of Rs. 5 lakhs was insufficient in the present condition due to hike in the cost of raw materials and revision in the estimate rates.

In the circumstances Government are pleased to revise the upper limit of MPLADS works executed through the beneficiary committees of Panchayati Raj Institution without tender process from Rs. 5 lakhs to Rs.15 lakhs. District

Authorities shall have the freedom to decide on entrusting the MPLADS works to beneficiary committees of PRIs under LSGD procedure.


