**ORDER No. E22 (Tech)/101/2013/CE/LSGD (2) Dated 01/01/2014**

Smt. C.C. Lissy and Sri. K. Gopalakrishnan, 1<sup>st</sup> Grade Overseer had submitted representation to correct the anomaly regarding the seniority list of 1<sup>st</sup> Grade Overseer published vide reference 2<sup>nd</sup> and 3<sup>rd</sup> cited respectively.

Smt. C.C. Lissy was promoted as 1<sup>st</sup> Grade Overseer with effect from 28/02/2006 vide order No. A4/31255/2004, dated 12/06/2006 of the Chief Engineer, Irrigation and Administration, Thiruvananthapuram and her seniority in the seniority list of I&A was corrected as 128 (b) as per Order No. ICI-9230/06 dated 05/04/2006. In the seniority list of this department the date of assignment of the incumbent in the cadre of 1<sup>st</sup> Grade Overseer was noted as 12/05/2006 instead of 28/02/2006. Hence it is decided to reassign the rank of Smt. C.C. Lissy in the seniority list of 1<sup>st</sup> Grade Overseer published vide reference 2<sup>nd</sup> cited from rank No. 206 to rank No. 198 (a) under certificate quota with date of assignment as 28/02/2006.

Sri. K. Gopalakrishnan was absorbed from Municipal Common Service to LSGD as 2<sup>nd</sup> Grade Overseer. In the seniority list of 2<sup>nd</sup> Grade Overseer published by the department on 31/12/2009, he was at rank No. 150. He had submitted petition against the seniority list that he has to be included in the seniority list as immediate junior to Sri. P.B. Ravikumar bearing rank No. 104 in the seniority list of 2<sup>nd</sup> Grade Overseer and filed WP(C). In the judgment the court dismiss the writ petition leaves open the petitioners contentions and reserving liberty with him to file an appeal challenging the rank and seniority assigned to him in the final seniority list published by the Director of Urban Affairs on 31/07/2009.

The Chief Engineer, LSGD had addressed the Director of Urban Affairs regarding the matter and reply received that Sri. K. Gopalakrishnan is eligible for seniority as immediate junior to Sri. P.B. Ravikumar.

Sri. K. Gopalakrishnan was promoted as 1<sup>st</sup> Grade Overseer on 12/05/2010 while Sri. P.B. Ravikumar had been promoted as 1<sup>st</sup> Grade Overseer on 31/12/2009. In the final seniority list prepared and published vide reference 2<sup>nd</sup> cited, based on these promotions, Sri. K. Gopalakrishnan bears rank No. 93 & Sri.P.B Ravikumar bears rank list of 67 under certificate quota. In these circumstances, it is hereby decided to re-assign the rank of Sri. K. Gopalakrishnan in the cadre of 1<sup>st</sup> Grade Overseer from rank No. 93 to 67 (a) in the seniority list of 1<sup>st</sup> Grade Overseer under certificate quota, published vide reference 2<sup>nd</sup> cited.

The objections were called for regarding the re-assignments of ranks of Sri. C.C. Lissy and Sri.K. Gopalakrishnan vide notice reference 1<sup>st</sup> cited. No objection was received till date. In this circumstance, it is decided to confirm and finalize the ranks re-assigned to Smt.C.C. Lissy and Sri.K. Gopalakrishnan.
