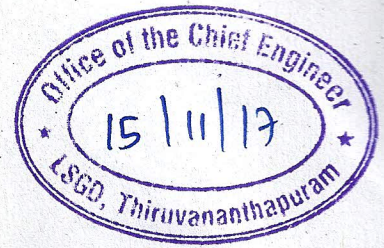

LSGD - Engineering Wing - Establishment – Regularisation of provisional promotions in the cadre of Assistant Executive Engineers - Orders issued.

ORDER

Special Rules prescribing the qualification, method of appointment etc, for appointment to the post of Assistant Executive Engineer in the LSGD Engineering Wing was issued as per G.O read as 1st paper above. In the said Special Rules, separate ratio for the promotion to the category of Assistant Executive Engineer from among direct recruitees and diploma holders in the feeder category (Assistant Engineer) was not specified. Due to this omission, the seniority list of Assistant Engineers could not be prepared for effecting the promotion. Hence, an amendment was made namely Kerala Local Self Government Engineering Service (amendment) Special Rules 2009 and was notified as per GO read as 1st paper above, incorporating the note in Sub rule (1) of rule 3 after category 4 that “promotion to the category of Assistant Executive Engineer shall be made from among direct recruitees and diploma holders in the feeder category in the ratio 3:1”.

2. Challenging to the above amendment WP(C) No. 24284/09 was filed by some diploma holding, Assistant Engineer and others in the Hon'ble High Court. The Hon'ble High Court vide Interim Order dated 25.08.2009 stayed the operation of the amendment made in the Special Rules for Kerala Local Self Government Engineering

Service and also ordered not to finalise the provisional seniority lists of Assistant Engineer's until further orders. However, the Hon'ble High Court of Kerala in I A No. 2276/10, dated 24.02.2010 ordered that the orders dated 25.08.2009 contain no rider or prohibition to consider the question of effecting provisional promotion without considering the note introduced in Sub rule 1 of rule 3 after category 4 of the special rules in accordance with law.

3. In compliance with the order of the Hon'ble High Court dated 24.02.2010 and in relaxation, of the existing ban of provisional promotion, Government considering the acute shortage of Assistant Executive Engineers, accorded provisional promotion for 66 Assistant Engineers as Assistant Executive Engineers as per GOs read as 2nd and 3rd above in the vacancies available at that time, by considering a common seniority among direct and diploma holders in the feeder category, ie Assistant Engineer. Later, 40 more Assistant Engineers were provisionally promoted as Assistant Executive Engineers vide read as 4th above. In this stage the provisional promotion of the Assistant Engineers as Assistant Executive Engineers made as per 2nd and 3rd above was reviewed in compliance with the order of the Hon'ble High Court in IA No. 3351/2010 dated 07.04.2010. The review was done in such a way that, stage I promotees ie, 66 and stage II promotees ie, 40, altogether (106 nos) are arrayed in the ratio 6: 3 ratio from among the degree holders and diploma holders as per the above orders of Hon'ble High Court.

4. In the mean time, the WP(C) No. 24284/09 existed at the Hon'ble Kerala High Court in this regard was transferred to the Hon'ble Kerala Administrative Tribunal, Thiruvananthapuram. The Hon'ble Kerala Administrative Tribunal, vide orders dated 28.10.2014 quashed the amendment made to the special rule vide GO read as 1st above and also the provisional seniority list of Assistant Engineer published by the Chief Engineer, LSGD. The above orders was up held by Hon'ble High Court of Kerala in OP No. 111/15 dated 31.03.2015.

5. However, the Hon'ble Supreme Court of India, vide Interim order read as 5th above has ordered that "operation of the impugned orders shall remained stayed. Promotion if any may be made as per the rules existing prior to the impugned judgment, but the same will be subject to further order from this Court".

6. Based on the interim order of the Hon'ble Supreme Court, the Chief

Engineer, LSGD has prepared and published the seniority list of Assistant Engineers, including that of the provisional promotees as per order read as 6th above. The above seniority list was published subject to the condition that the final seniority list is liable to be modified in accordance with the final verdict of the Hon'ble Supreme Court of India.

7. However, the Departmental Promotion Committee held on 12-10-2017 for preparing select list for regularising the provisional promotions ordered in the year 2010 has observed that the above interim orders will have to be scrupulously followed in the case of future promotions in the cadre of Assistant Executive Engineer only and the preparation of Select list for the year 2010 for the purpose of regularizing the provisional promotions already given can be done as per the ratio prevailed at the time granting of those provisional promotions. Accordingly, the Committee has approved the select list of eligible officers, for regularising the provisional promotions ordered in the year 2010 by applying the 6:3 ratio among direct recruitees and diploma holders in the cadre of Assistant Engineers, in pursuance to the order of the Hon'ble High Court in IA No. 3351/2010 dated 07.04.2010.

8. In the above circumstance, 89 provisional promotees who were included in the select list 2010, as detailed in the Annexure to this order is regularised with effect from the date shown against their name in the list. The regularisation of the above provisional promotions will be liable to be modified in accordance with the final verdict of the Hon'ble Supreme Court of India, if found necessary.


