Sub: LSGD – Estt – Promotion of Senior Clerks as Junior Superintendents – orders issued.

ORDER No. A1/1002/CE/LSGD Dated 17. 12.2013


Government in LSGD vide order read first above have accommodated 18 posts of Junior Superintendents from Public Works Department. These 18 posts of Junior Superintendents have been abolished in PWD accordingly.

Now Government vide order 3rd referenced have accorded sanction for granting temporary promotion to the eligible Senior Clerks as Junior Superintendent under Rule 31 (a))(i) Part II KS & SSR 1958 provided that they shall be optees and they shall be promoted only against vacant posts.


As per the provisional seniority list of Senior Clerks published vide order 2nd above there are 70 qualified Senior Clerks. At present there are 9 vacant posts of Junior Superintendent various LSGD offices. Also the service of 9 Junior Superintendents working in LSGD on temporary deployment have been terminated and they have been repatriated to PWD and posted to various PWD offices vide order referred 5th above. As a whole there are 18 posts of Junior Superintendent in L.S.G.D. Under the circumstances stated above 18 senior most clerks are hereby temporarily promoted as per Rule 31 (a))(i) Part II KS & SSR 1958 and posted to stations noted against their names. The promotion of Sri. Anilkumar N. shall be reviewed subject to the Government decision and the promotions of Smt. Annamma C S, Sri. Sudarsanan K A, Sri. Shajahan M., shall be reviewed subject to the Government decision on the order of the Honourable Kerala Administrative Tribunal on OA vide reference 4th cited. The officers concerned can download the orders from the website “www.celsgd.com” for effecting relieving/joining. The 9 Junior Superintendents who are repatriated to PWD vide order cited 5th shall be relieved immediately without waiting for the substitute join after making suitable charge arrangements.

The drawing and disbursing officers concerned shall obtain an undertaking from the incumbent promoted to the effect that he/she agrees to refund, in lump, any excess amount drawn on account of this promotion that may be found consequent in any change in the date of effect of promotion.

The date of relieve/joining may be reported in due - course.
