The incumbents whose names are noted in the ANNEXURE attached to this order were advised by the KPSC and appointed as Second Grade Overseers in this Department. As per the paper read 1st above the Regional Officer, KPSC, Regional Office, Ernakulam has issued certificates to these incumbents stating that the identity of that candidates who had been advised for appointment to the post of Second Grade Overseers as per the advice letters noted against their names had been verified with the records kept in KPSC and are found correct.
